**'Ahlan Modi' event scaled down due to inclement weather in the UAE**

**DUBAI, FEB 12 /--/** The Ahlan Modi' community event to be addressed by Prime Minister Narendra Modi on Tuesday in Abu Dhabi has been scaled down due to inclement weather conditions in the UAE, an official involved in preparations said on Monday.

The event Ahlan Modi' (Hello Modi in Arabic) was scaled down after heavy rains and flashes of lightning were reported across the UAE overnight, causing traffic snarls and waterlogging. Community leader Sajeev Purushothaman told PTI that preparations for one of the biggest diaspora events of Prime Minister Modi ever at the Zayed Sports City Stadium in Abu Dhabi were going fine but the participation was reduced from 80,000 to 35,000 because of the weather. It was earlier reported that 60,000 people had already confirmed, via a website set up to register attendees, to attend the event to be attended by only Indian-origin persons. According to Purushothaman, between 35,000 and 40,000 persons, including those presenting cultural programmes, will attend the event. He added that more than 500 buses will operate, with over 1000 volunteers at the venue. A source in the Indian Embassy in Abu Dhabi said 45,000 people will attend the public event to be addressed by the prime minister. Prime Minister Modi along with then US President Donald Trump addressed a massive community event called 'Howdy, Modi!' in Houston, Texas on September 22, 2019. (PTI)

**Pak's election commission releases party positions of controversial polls after 3 days**

**Imran Khan's party to sit in Oppn; rules out joining any coalition govt**

**ISLAMABAD, FEB 12 /--/** Pakistan's election commission on Monday released the full results of the controversially-marred general elections, giving the preliminary position of all political parties in the national and provincial assemblies.

The general elections were held on Thursday, but there was an unusual delay in the announcement of results which led to allegations of vote rigging at many constituencies across the country. While both jailed former PM Imran Khan's Pakistan Tehreek-e-Insaf (PTI) party and ex-premier Nawaz Sharif's Pakistan Muslim League-Nawaz (PML-N) has claimed victory; a coalition government appears inevitable as no single party has got the majority in the National Assembly.

Imran Khan's Pakistan Tehreek-e-Insaf party will not join hands with rival PML-N or the PPP to form a coalition government and would sit in the Opposition despite having a majority in the newly elected Parliament, party leader Barrister Gohar Ali Khan has said.

Independent candidates, mostly affiliated with Khan's PTI, secured the most parliamentary seats in last week's general election. However, PTI does not have enough seats in the 266-member National Assembly to form a government on its own. "We don't feel comfortable with both (Pakistan Muslim League-Nawaz and Pakistan People's Party) of them. There will be no talks with anyone to make a government or to make a government together with them. It is better to sit in the Opposition than to make a government [with them], but we think we have the majority," Gohar Khan told Dawn News.

Voting was held on 854 national and provincial assembly constituencies. According to the initial results, 348 independents returned successfully. Independent candidates, a vast majority of them were backed by Khan's PTI. (PTI)
